Eisenhower Career Day







Today at 11:20 AM, #GardenGrovePD officers were at the Haster Basin Park (12952 Lampson Ave.) looking for a person related to an on-going investigation. As officers approached a group of male transients, one of them ran, jumped a fence and went into the rain swollen flood basin. Officers watched the subject start to struggle as he tried to swim across the basin towards the opposite side. They lost visual of him and were not certain if the subject had drowned.

A water rescue team and Orange County Sheriff's Department, CA air support were requested to assist with the search. The helicopter arrived on scene and located the subject hiding under some shrubbery near the shoreline. He was found exhibiting symptoms of hypothermia and was assisted out of the water by rescue personnel and taken to a local hospital for treatment.

The subject was later identified as James Harvey, a 31-year old transient from Garden Grove. Harvey was wanted for several arrest warrants that included charges for grand theft, burglary, under the influence of drugs, and false representation. MOURNERS GATHER TO PRAISE FIRE CHIEF

More than 1,000 pay tribute to Tom Schultz at a memorial service in Fullerton



His children remembered him as someone who always encouraged them to do their best. Colleagues mentioned his faith, compassion and level head. A fire service chaplain recalled his fastidiously organized desk.

More than 1,000 admirers - several hundred representing fire departments throughout Southern California - gathered Wednesday to share memories of Garden Grove Fire Chief Tom Schultz.

Schultz's death on Jan. 27 stunned family members and friends, coming just two weeks after an unexpected diagnosis of stage 4 pancreatic and liver cancer. The Placentia resident, 54, left behind wife Kim, two daughters and a

dozens of firetrucks lined up outside, some of them having delivered bagpipers and eulogizers.

Schultz was well known in the Orange County fire service community, and beyond. Over 30 years, he climbed the ranks to deputy chief of operations for the Fullerton Fire Department, overseeing a consolidation of command staff with the Brea Fire Department. In 2015, Schultz ioined Garden Grove.

Meanwhile, for 25 years, he trained hundreds of future firefighters as an instructor at Santa Ana College.

"Tom was a tremendous influence on my career," Fullerton Fire Department Capt. Wade Fisher told the audience. "He pushed me to advance even when I didn't want to be pushed."

Fisher described Schultz

at the fire station kitchen table. After Fisher successfully performed the Heimlich maneuver, he recalled. "Tom calmly said 'thank you' and just kept eating."

Garden Grove City Manager Scott Stiles said that "fire chief is a tricky job."

"You have to be part firefighter, part politician and part administrator," Stiles said. "Sometimes, you have to make unpopular decisions."

Ever fair to all sides, he said, Schultz approached potentially sticky situations by objectively looking at the "memorandum of understanding" agreement between the city and its employees.

For him, the MOU was a firm handshake," Stiles said. "It doesn't matter which perspective is more beneficial to you: what does the MOU say? I learned from that. Now I start with, 'What's in the MOU?"





Sweethearts celebrate early at H. Louis Lake Senior Center

Celebrating an early Valentine's Day are Sam Flores and Sally Melendrez.

The couple began dating six months ago.

What do they love?

Dancing.

The two were among many celebrating the most romantic holiday of the year at the H. Louis Lake Senior Center in Garden Grove on Saturday.

Melendrez said she loves her friend's personality and that he's easy-going and loves to dance like she does. Also, he doesn't drink or smoke.

"We met at a bar in Carson where there was dancing," said Melendrez, "Then, I introduced Sam to the Garden Grove Senior Center to dance because the people here are friendly and we like the live band."

Melendrez, a caregiver, originally had a caregiver job in Gar-

den Grove. "I would bring the lady to the Garden Grove Senior Center five days a week for the daily activities and I also helped serve the lunches here," she said. "In the evenings, I would attend the dances to visit with the friends I met at the Senior Center, because I worked during the day."

She shared that regulars at the Senior Center have become close friends and often visit in each other's homes.

Flores, a Native American, is from the Purepceha Yaqui Nation from the South of Mexico, but he grew up in Orange County, attending Anaheim and Saddleback High Schools.

He's retired from working in electrical-mechanical drafting and now makes Native American medicine boxes from cedar wood because the cedar protects the sacred ceremonial properties stored in the boxes, such as spe-

cial tobacco, peace pipes, sage and special ceremonial feathers.

"Sam has begun sharing some of the American Indian ceremonies with me," said Melendrez.

Transient tries to swim away from arrest

A TRANSIENT tried to swim away from Garden Grove police Wednesday morning by jumping into the Haster Street Park basin.

A fugitive who sought to evade capture by jumping into the rain-swollen Haster Street Park Basin in Garden Grove on Wednesday morning was rescued and arrested.

According to Lt. Carl Whitney of the GGPD, the suspect is identified as Jason James Harvey, 31, a transient from Garden Grove.

At 11:20 a.m., officers were at the basin – located at Haster Street and Lampson Avenue in the eastern part of the city – looking for a man related to an ongoing investigation.

As officers walked toward a group of transients at a gazebo, one of them ran from police and jumped into the basin and started to swim away.


The fleeing swimmer tried to make it to the opposite bank but began to struggle and officers lost sight of the man. "The water temperature was extremely cold at the time and it started to rain," according to Lt. Whitney. "Officers were not certain if the male subject drowned."

A fire department water rescue team was called and a police helicopter deployed as well to search for the man. An Orange County Sheriff's Department's helicopter located the suspect hiding under some shrubbery near the shoreline.

Fire department personnel helped him out of the water. Suffering from symptoms of hypothermia, he was taken to a local hospital for treatment.

It was determined that Harvey was wanted on several arrest warrants including grand theft, burglary, being under the influence of drugs and false representation. He was also charged with running from police and trespassing.

On a busy night the Garden Grove City Council charged through the agenda Tuesday, renaming an area of the community, selecting members for an ad hoc committee to plan the future of the Willowick Golf Course and mulling the idea of keeping city hall open every Friday.

The council, on a 7-0 vote, approved a request from the Korean Chamber of Commerce to change the name of a commercial strip from "Korean Business District" to "Koreatown" and make the name changes on two monument signs on Garden Grove Boulevard.

(https://orangecountytribune.files.wordpress.com/2016/07/gg-logo_lg.jpg)The area is generally thought to be along the boulevard between Brookhurst Street and Beach Boulevard.

Also on Tuesday, the council agreed to appoint Mayor Steve Jones and Councilmembers Phat Bui and Kim Nguyen to serve on Garden Grove's half of a six-member committee to work with counterparts in Santa Ana to advance planning for the possible reuse of the 101.5-acre Willowick Golf Course. It's owned by the City of Garden Grove, but is located within Santa Ana city limits.



The council also approved a list of appointments to city commissions and the administrative board of appeals, and gave second and final approval to ordinances which regulate street vendors and crack down on building code violations.

Finally, the council discussed a proposal by Councilman George Brietigam to consider having city offices open each Friday, instead of alternate Fridays, as has been done since 1991.

After considerable conversation, it was decided to table the idea until "after budget" and other pressing issues are settled.

The next meeting of the city council is scheduled for Feb. 26.

Kicking the rust from the 'skeleton'



For over a decade, the "rusty skeleton" was Garden Grove's least popular landmark. The steel bones of an unfinished structure, festooned with graffiti, the building on Garden Grove Boulevard was a sort of poster child for busted dreams. But on Tuesday, the first symbolic steps were taken toward making that eyesore into an eye-catching attraction at a groundbreaking ceremony for the Garden Brook Senior Village.

Originally conceived as a mixed-use condo project located just west of Brookhurst Street called the Garden Grove Galleria, the building is being reborn as nearly 400 units of senior citizen housing – most of it classified as "affordable" – fronted by several ground-level units of retail.

Developer Alexis Georgian of AMG & Associates led off the proceedings speaking of how the location of the reborn project adjacent to the Boys & Girls Club of Garden Grove facility, would allow for a multi-generational interaction that would benefit the elderly and the young.

"This is not an ordinary senior citizen housing project," he said.

City Manager Scott Stiles said "This is a great day and a great occasion for Garden Grove. He added "if there's one site, one

project that I've heard more about than any other site in Garden Grove since I've been here, it's 'the steel skeleton.' And probably with this groundbreaking, in my mind, we're removing one more psychological barrier in our drive to reimagine Garden Grove in a big way."

The origin of the project goes back decades. The land on which it is located is owned by the Hoag Foundation, which is the benefactor of the local Boys and Girls Club.

Used for years as the rented home of car dealerships, the land was later earmarked for the Galleria with a 2006 starting goal. Construction began, but stopped with the onset of the Great Recession in 2008.

Much legal wrangling took place, and at one point, the City of Garden Grove was poised to require the abandoned project to be demolished.

Eventually, developers, financing and managers were located and assembled, and the next — and hopefully last — leg of the journey is underway.



League President Arbuckle and Executive Director Coleman Join State Municipal Leagues to Build Relationships with New Congress

February 11, 2019

League of California Cities® President Jan Arbuckle, council member, Grass Valley, and League Executive Director Carolyn Coleman joined more than 40 executive directors and local leaders from 19 state municipal leagues across the country in Washington, D.C. for National League of Cities' (NLC) third annual state municipal league fly-in, where they met federal decision-makers and discussed city priorities.

Through meetings and a briefing on Capitol Hill, state municipal league partners and NLC staff advocated for NLC's top legislative priorities, including infrastructure investment, preventing future federal government shutdowns and broadband expansion. Together, they ensured that federal decision-makers heard loud and clear that city advocates are ready to build local-federal partnerships that will help to move America forward.

"Last week's meetings in D.C. were a great opportunity to meet with legislators and highlight pressing issues that California residents, and America's communities, are facing every day," said League President Jan Arbuckle. "Through the fly-in, we were able to build strong relationships with newly elected members of Congress and build a national narrative around the value of strong infrastructure."

The fly-in began on Wednesday, Feb. 6, with a briefing hosted by NLC's Federal Advocacy staff who provided an update on the current political dynamics in Washington, D.C. and potential for an infrastructure package this year, as well as substantive updates on NLC's 2019 federal legislative priorities.

On Thursday, the state league leaders descended on Capitol Hill for a day of action to advocate for city priorities. They came prepared with the stories of their communities and residents, eager to amplify their voices and city priorities in the on-going policy and legislative conversations happening in the nation's capital. In meetings with members of Congress and congressional staff, the attendees presented NLC's guiding principles for rebuilding and reimagining America's infrastructure and 50 ideas for what cities need in an infrastructure plan. They also educated members of Congress and congressional staff about the roles and responsibilities of cities. In their time on the Hill, state league leaders met with more than 45 congressional offices across 21 states, and built relationships with 23 newly-elected members of Congress.

Local and federal leaders have a tremendous opportunity this year to come together and drive forward-thinking legislation that serves all of America's communities. The fly-in helped build strong relationships with many newly-elected members of Congress and jump-started national conversations around rebuilding and reimagining America's infrastructure.

On March 10–13, all of the League's Officers will travel to Washington, D.C. for the <u>Congressional City Conference (CCC)</u> to learn about common challenges affecting cities and meet with federal representatives and their staff to discuss federal policy issues of greatest importance to cities and local governments.

Competing Use of Force Bills Introduced in Legislature

February 11, 2019

The use of force among law enforcement has become a hot-button topic nationwide in the past few years.

This controversial and emotional issue will carry on in the state Legislature with two competing proposals, AB 392 (Weber) and SB 230 (Caballero).

AB 392, introduced by Assembly Member Shirley Weber (D-San Diego), seeks to revise the legal standard for use of deadly force by peace officers. This bill is considered a reintroduction of AB 931 from 2018, which Weber introduced in the wake of the Stephon Clark shooting incident in Sacramento.

Law enforcement groups acknowledge that the current use of force statute, established in 1872, is in need of an update. The bill they are sponsoring, SB 230 by Sen. Anna Caballero (D-Merced), seeks to modify California's requirements for employing deadly force in a manner that reflects the decisions of the United States and California Supreme Courts. SB 230 also calls for more police training and an emphasis on trying to calm suspects before resorting to lethal force.

These two bills will likely be heard in the Senate and Assembly Public Safety Committees. The League will continue to monitor these bills as they progress and provide updates in CA Cities Advocate as available.

Looking to Update Your General, Specific, or Community Plan?

State Planning and Technical Assistance Grant Funding will be Available this March

February 11, 2019

Starting this spring, cities can apply for funding through the <u>SB 2 Planning Grants Program</u> to update general plans, community plans, specific plans, local planning related to implementation of sustainable community strategies or local coastal plans.

The purpose of this program is to provide funding and technical assistance to local governments in California to help prepare, adopt and implement plans and process improvements that streamline housing approvals and accelerate housing production.

SB 2 (Atkins) aimed at addressing the state's housing shortage and high housing costs by establishing a permanent funding source for affordable housing. Half of the funding generated in year one will be available to local governments through noncompetitive grants. The year two funding will allocate 70 percent of the funding towards local governments for affordable housing purposes. A large portion of year two allocations will be allocated using the same formula used to allocate federal Community Development Block Grants.

The Notice of Funding Availability (NOFA) for year one will be released in March 2019. Funding will go out to cities beginning in summer 2019, and the <u>SB 2 Planning Grants Program Year One Guidelines</u> are available for review now.

The League will be hosting a webinar with the Department of Housing and Community Development (HCD) and the Institute for Local Government (ILG) in early April to walk cities through the application process. A webinar announcement will be available next week.

What Can This Funding Be Used for?

Eligible activities may include:

- Updates to general plans, community plans, specific plans, local planning related to implementation of sustainable community strategies or local coastal plans;
- Updates to zoning ordinances;
- Environmental analyses that eliminate the need for project-specific review; and
- Local process improvements that expedite local planning and permitting.

How Much Money Can Cities Receive?

The revenues from SB 2 will vary from year to year, as they are dependent on a variety of real estate transactions with fluctuating activity. Therefore, the minimum and maximum award amounts may be adjusted. Currently, the fees are estimated to generate approximately \$250 million per year.

The minimum award is \$25,000.

The maximum award amount will be adjusted on a sliding scale based on population estimates from the Department of Finance as follows:

- \$500,000 for large localities (greater than 200,000 people);
- \$250,000 for medium localities (60,000 to 200,000 people); and

• \$125,000 for small localities (less than 60,000 people).

Eligibility

The program will provide grants to cities and counties through a noncompetitive process to those localities that can demonstrate that their eligible activity has a nexus to accelerating housing production.

Eligible applicants must meet these requirements:

- Have an HCD-compliant housing element;
- Have submitted a recent Annual Progress report;
- Must demonstrate a nexus to accelerating housing production; and
- Must demonstrate that the applicant is consistent with State Planning Priorities or other planning priorities.

Applicants not meeting housing element requirements may be considered at the discretion of HCD and based on factors such as significant progress in meeting housing element requirements.

Partnerships

Local governments can also partner with other localities, regional governments, housing authorities, school districts, special districts, community based organizations, or any duly constituted governing body of an Indian Reservation. Applicants seeking partnerships with other local governments will be additive. For example, two large localities could submit a proposal for up to \$1,000,000.

Application Review

Applicants must submit an application to be eligible for funding. An application form will be available upon release of the NOFA and will include forms to demonstrate meeting threshold requirements, a proposed budget and timeline, and a request for letters of support from key stakeholders and decision-makers in the adoption process.
