



Directly to the south, is Cesar Chavez Campesino Park.




GGUSD Announces Air-Conditioning Schedule Set for 2020 Completion

Garden Grove Unified School District's Board of Education recently announced the district's schedule to complete air conditioning (a/c) in all schools by 2020. Currently 56 campuses have school-wide air conditioning with the remaining 12 schools set to receive a/c during the summer of 2019 and 2020.

The schedule of completion includes Crosby, Evans, Excelsior, Morningside, Murdy, Peters K-3, and Riverdale elementary schools which are set to receive a/c during the summer of 2019, and Brookhurst, Cook, Lawrence, Marshall, and Mitchell elementary schools to receive a/c during the summer of 2020.

Just five years ago, only 15 of the district's schools had a/c. Most GGUSD schools were built prior to a/c becoming a standard element of school design and construction. In 2010, GGUSD voters approved Measure A, the district's first bond measure which paved the way for a/c by upgrading infrastructure and electrical systems. The Board of Education made a commitment to bring a/c to all schools beginning with an allocation of district facility funds to get started. The successful passage of the district's second bond measure, Measure P, in 2016, will provide for the completion of district-wide air conditioning.



Congratulations to the La Quinta Girls Volleyball team who won the Garden Grove League Championship last week. They finished the season off strong, winning their final five matches, and ended with an 8-2 league record. They face a very familiar foe in the first round of the CIF-SS Division 7 Playoffs this Thursday – Garden Grove, who finished third in the Golden West League.

FIRE DEPARTMENT INCIDENT

Fire fighters responded to the 12000 block of Le Ann Drive shortly after 7:00 a.m. this morning for a residential structure fire. The first-arriving engine company reported fire showing from a single story house, and initiated an attack of the fire and a search for residents. It was later determined that no one was home at the time of the fire. It took 20 fire fighters to get the fire under control 23 minutes later.

Two Garden Grove police officers were first on scene, and attempted to make entry to search for residents. They sustained smoke inhalation in their effort. The officers were treated by fire fighter paramedics, and transported to a local hospital for further evaluation. Both were in stable condition. There were no other injuries reported. Fire investigators are on scene, and investigating the cause at this time. Damage to the structure is estimated at \$100,000 and \$25,000 to contents. Assistance was provided by Anaheim Fire And Rescue.



Shakespeare Orange County gets bumped from Garden Grove Amphitheater for reggae, rock concerts

It looks as though Shakespeare Orange County also has reached its final act at least at the Garden Grove Amphitheater, its host for almost 30 years.

The city has inked an agreement with concert promoter LFA Group to operate the open-air arena in Village Green Park for the next decade. That deal replaces a less formal arrangement Shakespeare O.C. enjoyed with Garden Grove to maintain the amphitheater while providing entertainment there.


"Originally, the city said, 'We're bringing in this promotion company, but we always want to keep Shakespeare during the summer,'" said John Walcutt, Shakespeare O.C. artistic director. "We agreed to shrink our season from five months to two months."

But then, Walcutt said. LFA promised only a couple of weekends - a limited offer that would not be worth the time required for prep-

"Plays aren't like concerts," he said. "You need to rehearse a lot - and you need a stage to rehearse

Already, Shakespeare O.C. was squeezed out of the amphitheater this past summer, Walcutt said. Still. he hoped the city would throw a lifeline for next summer until he learned otherwise in a recent meeting with officials.

Brainiac might be weird, but we are so looking forward to our new garbage can. We probably are weird, aren't we?

Here's the deal, though. The Midway City Sanitation District. which serves Westminster, is finally ready to roll out its new green organics waste bins, which are not, you may be surprised to learn, just for organic peas, zucchini, lettuce and string beans.

Oh, no; the green we're talking about here has to do with organic materials that easily can be broken down into reusable byproducts. So the new can is where you'll put your yard waste - grass clippings, weeds, pruning and other lawn and garden materials — as well as kitchen castoffs, fruits and vegetables, meat and dairy, even fats, oils and grease.

There's no change in the cost you'll pay for garbage collection, but the green cans will help the district meet a recent state law that requires California governmental agencies to divert 50 percent of their solid waste from landfills by 2020, with

green waste one of the most achievable means of doing so.

And your trash today might power your neighborhood garbage or recycling truck tomorrow. The contents of the green waste bins will end up at the CR&R Anaerobic Digestion Facility in Perris,

where it will be converted into renewable natural gas.


safety and deal with other problems caused by state decisions to release more and more prisoners back into the communities from which they came, city officials say.

If Measure O passes, the money will be earmarked for programs such as 911, improving emergency response times and neigh-

borhood police patrols. It also will help avoid cuts to police, fire and paramedic staffing.

Other targets for spending potential Measure O funds include programs to protect local drinking water, fight gangs and drugs in the city, and work to help the homeless.

If it's approved, the city says, an oversight committee and annual audits will make reports to the community so residents know where their taxes are being spent.





Factors contributing to the city's rare position include newer infrastructure, abundant development fees and only one bond issue

Anyone with student loans, a mortgage or credit card debt daydreams of making that final payment and being debt-free.


For the city of Lake Forest, the dream is about to come true.

Once the city writes a \$6.7 million check in December to wipe out its bond debt (the money is already in the budget, pulled from reserves) and it pays less than \$1,600 in out-

standing pension obligations
— no zeros missing there —
officials can say Lake Forest
is beholden to no one.

Of the 482 cities in California, just 43 of them reported no debts in the 2015-16 fiscal year, which is the most recent data available from State Controller Betty Yee's office. But among those still debtfree, CalPERS shows only one also has no unfunded pension liability: Rancho Mirage, a wealthy enclave near Palm Springs, where the median age is 65.

Lake Forest is about to join that very small club, and Mayor Jim Gardner is thrilled about it.

"Every day you read about cities going bankrupt or having to cut services," Gardner said. "Being debt-free says to everybody: 'Don't worry, we can still carry on all the functions that a city needs."

So how did the city get into such a fortunate position, and could others replicate Lake Forest's success?

It took careful planning, City Manager Debra Rose said. But she acknowledged Lake Forest also has some contributing factors few cities can claim, making it unlikely that cutting up the municipal credit cards will become a trend.

"The council's always been fiscally conservative. ever since the city was incorporated" in 1991, Rose said. And, it has only issued bonds once — to build an extension bridging a gap in Alton Parkway.

As a newer city with about 84,000 residents, Lake Forest didn't have to build much of its infrastructure, and it contracts out most services, city spokesman Jonathan Volzke said.

The city opened a sprawling new sports park in 2014, and construction is underway on a multibuilding civic center, all paid for in cash, thanks to abundant development fees.

Older cities typically rack up debt to build and maintain public facili-

carry the salary and benefit costs of police officers. planners and park maintenance workers.

Sometimes borrowing is unavoidable, but "it's something hanging over your head, and you're paying an interest rate that is going to somebody else when it could be going to your city services," said Riverside Councilman Mike Soubirous, whose city owed \$1.6 billion in 2015-16.

The state controller's data showed Los Angeles owed the most of any city in the state, with \$24.5 billion in debt in 2015-16. Riverside's comparatively modest total still was enough to rank it the seventh most indebted in the state, ahead of Anaheim (\$1.2 billion), Irvine (\$953.6 million) and Glendale (\$270.8 million). council asked for a sales tax increase in 2016, Soubirous got it to make a "responsible spending" pledge that includes paying off debt and saving more.

Debt has found its way into the November election too, with candidates in council races around the region talking about how to trim budgets, pay off debt and find new revenue. More than a dozen Southern California cities are asking voters to increase local sales taxes to help pay for services.

Riverside got into a fiscal hole in part because prior administrations didn't always plan for future needs, Soubirous said, and "a lot of things came due at the same time." The 2006 "Riverside Renaissance" inities, and full-service cities erside's number, when the tiative sought to cram 30

years' worth of neglected upgrades to city facilities into five years, and it came with a big price tag.

Hoping to avoid that pitfall, Lake Forest officials want to save for when development slows and amenities such as the civic center and sports park are no longer new, Rose said, rather than spending or borrowing now that they are caught up.

As to Lake Forest's soonto-be-debt-free status, Soubirous said, "That's really something to shoot for, and that would be the envy, I think, of every council person in every city."

More California cities at least may be aiming to reduce their pension debt, CalPERS spokeswoman Amy Morgan said. Unfunded liability is the gap between the available dollars in a pension fund and the cost of benefits promised to workers and retirees.


The number of cities with fully funded pensions jumped from three in 2016 to eight last year. The statewide average funding level is 68 percent for police and fire and 71 percent for all other public employ-

"We are seeing an increasing number of cities that are looking forward" and paying in advance, Morgan said.

In Lake Forest, city officials may celebrate when they write that final check, but people are already talking about it.

"I brag to all potential buyers who don't know anything about Lake Forest," said real estate agent Tracy Bryant, who also lives in the city. "It says that someone didn't over-

Canine blood bank disputes abuse claims

GARDEN GROVE » The animal rights group PETA alleges that dogs at one of the nation's largest canine blood banks are mistreated, but the nonprofit that runs the Southern California facility says the retired racing greyhounds are wellcared for and save other dogs' lives.

People for the Ethical complaints this week to California and local authorities alleging the 200 greyhounds kept at Hemopet don't receive proper care and are cooped up nearly all day in pens too small for their size. The group contends confining dogs in a facility to draw their blood is wrong and says they should be placed in homes and only donate blood if their owners opt to bring them in.

Hemopet, which has operated for decades, said the dogs are well-cared for and get regular walks and outdoor play time at its 1.5 acre Orange County campus. The organization said the greyhounds participate in a state-regulated canine blood donor program for about 10 months before they are placed in well-screened adoptive homes.

there is a demand for canine blood to treat ill pets and those in need of emergency surgery. How to meet this need, however, is subject to debate.

"Community" blood banks rely on walk-in pet donors, while "closed" banks such as Hemopet require dogs to live on-site while giving blood. The controlled setting ensures blood is free of diseases.

California requires the closed model be used for commercial canine blood banks, said Hemopet's president, Dr. Jean Dodds. She said she believes pets living in people's homes would Treatment of Animals sent need to be retested for disease before each donation to provide a comparable level of safety, and even then it might not be possible to safeguard the supply.

Hemopet supplies about 40 percent of the commercial blood bank products sold in the United States and is one of two such authorized facilities in California, Dodds said.

Dodds said the greyhounds would be killed if they weren't rescued from the racing industry. Hemopet provides medical care and spays and neuters the dogs and screens them to assess whether they are suitable donors. Greyhounds often have a "universal" blood type, she said, which can be used for any canine transfusion.

In a letter to California's Department of Food and Veterinary experts said Agriculture, PETA alleged that dogs' tails, paws and nails are injured in small cages where they're kept 23 hours a day, and blood is drawn at times from animals suspected of illness.

Dykstra, known as "Nails" for his rough-and-tumble style of

play, was a world champion with the Mets in 1986 and a three-time all star as a centerfielder with the Phillies.

Since retirement from baseball, Dykstra forged a business career and has had troubles with the law, including serving time in prison after a no contest plea in 2011 to charges of bankruptcy fraud and money laundering.





A/C for all GGUSD schools by 2020

ALL THE campuses in the Garden Grove Unified School District will have air conditioning by 2020, the GGUSD has announced.

A schedule for the completion of air conditioning for all schools has been announced by the Garden Grove Unified School District. Currently 56 campuses have school-wide air conditioning with the remaining 12 schools set to receive a/c during the summer of 2019 and 2020.

The schedule of completion includes Crosby, Evans, Excelsior, Morningside, Murdy, Peters K-3 and Riverdale elementary schools which are set to receive a/c during the summer of 2019 and Brookhurst, Cook, Lawrence, Marshall

and Mitchell elementary schools to receive a/c during the summer of 2020.

(https://orangecountytribune.files.wordpress.com/2016/08/ggusdlogo.png)As recently as five years ago, only 15 of the district's schools had a/c. Most GGUSD schools were built prior to a/c becoming a standard element of school design and construction. In 2010, GGUSD voters approved Measure A, the district's first bond measure which paved the way for a/c by upgrading infrastructure and electrical systems.

The Board of Education made a commitment to bring a/c to all schools beginning with an allocation of district facility funds to get started. The successful passage of the district's second bond measure, Measure P, in 2016, will provide for the completion of district-wide air conditioning.



The first issuance of Measure P bond funds came in April 2017 and district leaders have worked hard to reduce the air conditioning implementation schedule down from 10 years to four years.

Proposed for the 2.71-acre site now occupied by a movie theater and a closed buffet restaurant is a project that would include an expanded movie complex, a new Jack In the Box fast food restaurant (with drive-through lanes), a sit-down restaurant and an automatic car wash.

Total seating for the cinema will be reduced from 627 seats to 326 seats to allow for stadium-style seating with recliner seats. The existing vacant eatery would be demolished to make room for the development.

The new sit-down restaurant has not been identified, and the closed bowling alley at the south of the site is not part of the project, located at 12101 and 12111 Valley View St., south of Chapman Avenue.

The commission meets at 7 p.m. in the council chambers inside the Community Meeting Center, 11300 Stanford Ave.

After 47 years, Garden Grove has a new fire station. Members of the community are invited to celebrate the opening of Garden Grove Fire Station No. 6, located in West Haven Park, at 12232 West Street. A reception and ribbon-cutting ceremony will take place on Tuesday, October 23, at 4:30 p.m.

"The opening of this new fire station is as exciting and meaningful to the community as it surely was in the 1970's because of the deep hometown pride and spirit that it evokes, which is timeless," says Garden Grove Mayor Steve Jones.

The new Fire Station No. 6 replaces the aging and nearly obsolete Fire Station No. 6 on Chapman Avenue, built in 1971. The new station is a full-function, 7,680 square-foot facility that includes an apparatus bay, front office, visitor lobby, laundry facility, kitchen and dining room, and bunk rooms. It will house Grove Engine 6, a 3-person paramedic assessment unit, with the capacity to accommodate up to eight daily personnel.

In addition to Fire Station No. 6, the City will also inaugurate a new, 1,815 square-foot multi-purpose community room, and a children's fire station- themed playground, located in West Haven Park, behind Fire Station No. 6.

Mayor Jones, along with members of the Garden Grove City Council, other elected officials, and former and current fire personnel will be in attendance. At the event, the City will unveil a replica of a 2.4-foot dedication plaque, to be installed at new the fire station at a later date.

Plans for the new station and park improvements began in 2015 with the authorization of a \$5.5 million Certificate of Participation (lease revenue) bond by the Garden Grove City Council, not utilizing the General Fund. In 2016, the City conducted a series of community meetings to determine a new site for Fire Station No. 6. The project broke ground on May 23, 2017.

Federal Communications Commission Sides with Wireless Industry on Policy that Erodes Local Control,

Lowers Standards for Deployment of Wireless Small Cell Equipment

The <u>Federal Communications Commission (FCC) voted 4-0</u> on Sept. 26 to limit the authority and standards that states and local governments can require for the installation and/or deployment of small cell wireless facilities. In 2017, Gov. Jerry Brown vetoed SB 649, similar legislation, after the League and a large coalition of cities voiced serious concerns that the bill would harm local communities. The <u>FCC approved its declaratory ruling and report order</u>, which will go into effect in 90 days and will:

- > Significantly shorten the period and likely overwhelm cities with thousands of complex small cell applications to process within 60 or 90 days;
- > Prohibit the ability for cities to impose fees for basic cost recovery for reviewing complex small cell applications to \$100 per site;
- > Prohibit cities from imposing fair market rates for the private use of taxpayer funded public property at \$270 for the installation of small cell wireless facilities; and
- ➤ Lower standards for aesthetic review and undergrounding, historic, and environmental requirements to those that are "reasonable, comparable" requirements for other rights-of-way users, and published in advance.

SB 649

The wireless industry last year pursued similar failed legislation (SB 649) in California that sought to achieve many of the elements present in this order.

The industry's effort was <u>met with overwhelming opposition from over 325 California cities</u> <u>concerned</u> about shifting authority away from residents, businesses, and communities over to a forprofit industry whose shareholder returns potentially outweigh their considerations for the health, safety, aesthetic, and public benefits of communities.

Opposition to FCC Order

<u>The League opposed the FCC order</u> along with many national organizations. <u>In a joint letter</u>, the National League of Cities (NLC), the National Association of Counties, the United State Conference of

Mayors, the National Association of Telecommunications Officers and Advisors, and the National Association of Regional Councils all urged the FCC to reject the order.

The letter stated that the order "undermines local governments ability to ensure fair and reasonable deployments, and fails to ensure any public benefits." The National Conference of State Legislatures and the National Governor's Association <u>also opposed the order</u> given the impacts to state governments and erosion of local control.

Cities throughout California and the nation share in the goal of ensuring that residents have access to affordable, reliable high-speed broadband and eagerly welcome installation of wireless infrastructure in collaboration with local governments.

However, this order will not help in achieving these goals. Instead, this order will interfere with local governments' management of their own property and their ability to receive fair compensation for its use. Local governments actively manage the rights of way to protect their residents' safety, preserve the character of their communities, and maintain the availability of the rights of way for current and future uses.

FCC Commissioner Action

There is additional reason to be concerned with this action. Commissioner Michael O'Rielly, in his prepared remarks, expressed his preference for further deregulation of the wireless industry and did not think this order went far enough. Mr. O'Rielly blamed local governments for imposing "exorbitant fees, ridiculous practices, and prolonged delays" and preferred to eliminate all environmental review.

In addition, he stated that he believes that the FCC should also look at loosening standards for larger Macro-Towers.

Commissioner Brendan Carr, who led the FCC's efforts, was also critical of local government's role in the deployment of small cell wireless technology and claimed that the order would speed the deployment of 5G. In his prepared remarks, he claimed that this order would cut red tape by \$2 billion nationally, allowing the industry to make additional investments.

No such requirements, however, are placed on the wireless industry to reinvest those savings into rural or suburban community deployment of this infrastructure. Instead, the \$2 billion in "savings" for the wireless industry simply prevents local communities from recovering the public's cost for reviewing and permitting such infrastructure and from placing fair market value for private use of taxpayer assets. **Next Steps**

For more information about the FCC's actions, the <u>NLC has highlighted the five key takeaways</u> and next steps for cities, now that the Order is adopted. The League and its local government partners will continue to explore administrative, legal, and legislative steps to stop the Commission's clear overreach.
