

# Scenes of Garden Grove (May 2022)

It's spring, and we're all enjoying the longer days that have not yet become as hot as we know they will, come summer!

The garden at the Stanley Ranch, diligently cared for by gardeners Brenda Konyak, Birgit Jordan, Barbara Gossett, and Lynn Blankenship, is in full bloom. The squirrels are chasing each other up the walnut tree, and bluebirds are darting in and out of the foliage above them, tending their nest (or so we assume; we haven't actually climbed up to check!).

Next to the ramp up to Emerson Hall is a "red hot poker," an aptly named native of Africa that's sometimes called "torch lily" and "poker plant," formally known as Kniphofia. Ours even attracted the attention of a barn sale shopper; unlike a previous customer at one sale who wanted to buy the barn, he did not offer to buy the plant!

And finally, the jacaranda trees are blooming all over the city and county. This drought-tolerant tree (once it's established) is native to Argentina, although its popularity is worldwide: There are jacaranda trees in Asia and Africa as well as throughout the Americas.

# NOTICE OF APPLICATION SOUTHERN CALIFORNIA GAS COMPANY'S REQUEST TO INCREASE RATES AND REVENUES FOR THE 2024 GENERAL RATE CASE APPLICATION FILING A.22-05-015

### Why am I receiving this notice?

On May 16, 2022, Southern California Gas Company (SoCalGas®) filed a General Rate Case (GRC) application with the California Public Utilities Commission (CPUC) requesting authority to increase revenues for 2024-2027. SoCalGas is requesting to increase revenues by \$767 million (20.9% increase over 2023 expected revenues) in 2024. This application also includes requested increases of \$292 million (6.6%) in 2025, \$267 million (5.6%) in 2026, and \$413 million (8.3%) in 2027. The cumulative requested revenue increase is \$4,889 million.

Every four years, SoCalGas is required to file a GRC application with the CPUC to set annual revenues. Annual revenues are the total amount of money a utility is allowed to collect through rates in a given year. The revenues requested in this application pay for the costs of owning and operating gas infrastructure (excluding the cost of purchasing natural gas for SoCalGas customers).

If the CPUC approves this application, SoCalGas will implement new revenues in gas rates beginning on January 1, 2024. This will impact your monthly bill.

### Why is SoCalGas requesting this rate increase?

• To continue to invest in its gas delivery system to enhance safety and reliability, and to manage risks that could impact its employees, customers, and/or system;

- To continue to invest in the needs of customers by enabling diverse customer service capabilities, and to empower customers with information and tools to better manage their gas use;
- To meet regulatory and compliance requirements driven by system safety and reliability and environmental compliance; and
- To invest in efforts and programs to maintain a highly-trained, qualified, and diverse workforce.

# How could this affect my monthly gas rates?

If SoCalGas's rate request is approved by the CPUC, the typical residential monthly bill using 36 therms per month would increase by approximately \$8.62 or 13.7% per month in 2024, compared to estimated 2023. Individual customer bills may vary.

### Proposed Gas Rate Increase

### How does the rest of this process work?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SoCalGas' application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SoCalGas' application, including the Public Advocates Office. The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. Affordable homes don't increase crime or dent Orange County property values, says UCI study

That's the perception UC Irvine professor George Tita, who heads the university's Livable Cities Lab, often hears – and a new study he and his colleagues just completed looks at affordable developments in Orange County to explore whether those assumptions are supported by facts.

The researchers will share key findings of the study Thursday in an event at Irvine City Hall. While there are nuances to the data, Tita said it lines up with other studies that show affordable housing doesn't drag down the quality of a community.

"Affordable housing at the very worst has no impact on crime or housing values," Tita said.

And, in many cases, he said, "there is a positive impact on the price of homes sold and the average price per square foot of homes sold in the three years after affordable housing is placed" in a neighborhood.

Researchers are still analyzing the data, but those are the top-line conclusions.

There could be several factors driving those results: high standards in regulations require affordable developments to look as nice or nicer than other housing in the community, and, as Tita pointed out, a quality new build is an investment in the neighborhood that might be replacing a disused lot or a run-down motel that saw frequent police calls.

Whatever is at the root of the findings, they're not a surprise to Lucy Dunn, the former head of the Orange County Business Council. She said she's been hearing arguments about home values and crime since she headed the state Housing and Community Development Department under Gov. Arnold Schawzenegger.

They stem from "fear of change and fear of newcomers," Dunn said, but in the early 2000s there weren't any studies to help put those fears to rest.

Now the issue has been looked at by a number of researchers (Tita said they've largely drawn conclusions that match his findings), but the UCI study is the first to specifically look at Orange County.

Tita said people are less likely to be persuaded by data from a different community in another state, and he hopes local policy makers can use the UCI study "to influence some skeptics on the issue."

### No negative impacts

The study was funded by several affordable housing developers, two nonprofits, the Orange County Housing Authority and the cities of Anaheim and Garden Grove. It focused on a list of 371 developments around the county that are designated as "affordable," which usually means tenants have to meet income guidelines or other criteria, and their rent is restricted or subsidized. Emergency shelters were not included.

While Irvine has the most affordable homes of any OC city, the study shows affordable developments are scattered around the county – but more heavily concentrated in the northern cities.

Using 20 years of sales data for homes within two miles of an affordable development (and adjusting to account for the 2008 recession and more recent home price explosion), researchers looked at what happened to values before and after an affordable development opened.

In lower-income communities, homes closest to an affordable site typically increased in value after the new housing was built, according to the study. In higher-income communities, the nearest homes sometimes saw their overall value decrease slightly after the addition of affordable housing, but the study said those tended to be larger homes. Generally the price per square foot actually went up, just as it did in poorer neighborhoods.

Orange County already has a lower crime rate than the state overall, Tita noted, and putting in affordable housing appears to either reduce violent crimes such as robbery and aggravated assault or have no impact.

Property crimes in some cases increased very slightly – say, one additional car breakin every two years within a fifth of a mile of the new housing – but Tita called the overall impact of that "imperceptible."

Irvine, which is consistently deemed one of the safest places to live, has been successful in its addition of affordable housing in part because, as a newer city, it's been able to incorporate lower-income homes as new developments are built – and that means often there aren't existing neighbors to object, said Councilman Anthony Kuo, who grew up in the city.

To meet city requirements, many market-rate developments include a small percentage of affordable units and the developments use the same quality of materials as any other housing, he said.

"That makes people part of the community," Kuo said. "No one's going to say, 'Oh well, that apartment building on the corner in the back is the poor people,' because we've deliberately incorporated those apartment communities into the greater community."

Steve Rosansky was on the Newport Beach City Council in 2015 when it approved over the objections of some in the neighborhood <u>a 12-unit complex in Newport Shores</u> for rent to veterans and seniors with lower incomes. There's been "no impact at all, from what I can tell, except some seniors have a very nice place to live," he said.

### One less barrier?

Michael Manville, associate professor of urban planning at UCLA's Luskin School of Public Affairs, said the findings of the UCI study aren't surprising for a few reasons.

Part of the lack of impact is due to "very strict quality controls" on affordable housing, he said, adding that not only is it highly regulated, "we put it in places where lower-income people are already likely to live."

There's some evidence that the addition of affordable housing can bring down property values in affluent, exclusive areas, Manville said, but not much – because it's so rarely allowed.

But, he added, "the purpose of public policy is not to keep your home value high."

Tita said the Orange County data is adding to existing studies that also have found that affordable housing is more likely to help boost the prices of nearby homes than the reverse.

"We hope that this study will eliminate one barrier to building more affordable housing in Orange County," he said. "We know that many others exist."

UCI Livable Cities Lab researchers will present their study findings at 3:30 p.m. Thursday in the City Council Chamber at Irvine City Hall, 1 Civic Center Plaza, Irvine. People are asked to RSVP <a href="here">here</a> to attend.

# Annual conference resolutions due July 9; time to designate a voting delegate

Jun 1, 2022

The General Assembly will be held on Sept. 9 during the League of California Cities Annual Conference and Expo.

Policy development is a key part of the League of California Cities' legislative effectiveness. Cal Cities' annual conference resolutions process is one way that city officials can directly participate in the development of Cal Cities policy.

#### Resolution submission process

Any elected or appointed city official, city council, division, department, caucus, policy committee, or the Cal Cities board of directors may submit a resolution for consideration at the Cal Cities Annual Conference and Expo. Resolutions must be germane to city issues.

Resolutions must be submitted via email to <a href="Meg Desmond">Meg Desmond (mailto:mdesmond@cacities.org)</a> no later than 60 days before the opening session of the annual conference.

Any submitted resolutions must have the concurrence of at least five or more cities, or of city officials from at least five or more cities, and those submitting resolutions must provide written documentation of such concurrence. This may be in the form of a letter from the city or the city official in support. For concurrence by a city official, the official's city and office held must be included in the letter. All documentation of concurrences must be submitted with the resolution.

The deadline to submit resolutions and concurrences for this year's conference is **midnight**, **July 9**.

Consideration at the Cal Cities Annual Conference

The Cal Cities president refers resolutions to appropriate Cal Cities policy committees for review and recommendation to the General Resolutions Committee (GRC). The GRC consists of one representative from each division, department, caucus, policy committee, and up to ten additional individuals appointed by the Cal Cities president. If the GRC approves a resolution, or if a resolution was approved by all policy committees to which it was referred, the resolution is then considered by the General Assembly.

If a resolution is not approved by the GRC and at least one policy committee to which it was referred, the resolution does not move to the General Assembly. The GRC may amend the resolution prior to moving it forward for consideration by the General Assembly. Resolutions approved by the General Assembly become Cal Cities policy.

#### Voting delegates

Cal Cities members consider and take action on resolutions that establish Cal Cities policy. In order for member cities to vote at the General Assembly, a city council must designate a voting delegate. Each city may also appoint up to two alternate voting delegates, one of whom may vote on behalf of the city in the event that the designated voting delegate is unable to vote.

A letter, along with the voting delegate form asking for the designation of voting delegates and alternatives, is being sent by mail to all city managers and city clerks. The voting delegate packet will be available online (https://www.cacities.org/Resources-Documents/Policy-Advocacy-Section/Policy-Development/Voting-Delegate-Packet.aspx).

### Late-breaking issues

Resolutions to address late-breaking issues may be introduced by petition at the Cal Cities Annual Conference and Expo. To qualify, a petitioned resolution must be signed by 10% of the voting delegates and submitted by 11:30 a.m. on Sept. 8 — 24 hours before the beginning of the General Assembly.

All qualified petitioned resolutions are forwarded to the GRC and the General Assembly for consideration unless the petition is disqualified due to a lack of required signatures, if the resolution is not germane to city issues, or if it is identical or substantially similar in substance to a resolution already under consideration.

# Catalytic converter theft bills clear key legislative hurdle

California lawmakers have introduced nearly a dozen bills that would address the continued rise in catalytic converter theft. Five of these measures unanimously passed their house of origin and will now be heard in policy committees in the second house. This is indicative of both the scale of the problem and the Legislature's eagerness to solve it.

Catalytic converters are often stolen because they contain precious metals and can be scrapped for a quick profit. According to the National Insurance Crime Bureau, which represents insurance companies, California is the top state for catalytic converter thefts.

State Farm reported a similar trend. The insurance company paid \$23 million to California consumers to cover associated costs in 2021, up from \$2.5 million in 2019.

In California, existing law makes it extremely difficult for local law enforcement officers to stop the sale of stolen catalytic converters. The Legislature is contemplating a variety of bills to address this tension.

If passed, these bills would enable law enforcement officers to better respond to catalytic converter theft calls and discourage sales on the black market.

Cal Cities has adopted a watch position for these two measures since it is unclear what level of deterrence they would create.

Legislators have rallied behind many of these measures, with many acknowledging that the Californians most impacted by this rise in theft are the very ones who can least afford it. Others have stated that current law has created an imbalanced risk-reward ratio for these kinds of thefts and that these measures aim to reconcile that.

In an effort to crackdown on interstate sales, SB 366 directs the California Department of Motor Vehicles to coordinate enforcement and compliance activities related to unlicensed vehicle dismantling with other state agencies.

# Emeryville's Development Bonuses code lays the foundation for increased housing

Jun 1, 2022

Like many cities, Emeryville's housing market is #LocalWorks out of balance. The supply does not come close to the demand. Emeryville has roughly 30,000

jobs, but only 12,905 residents. Both are expected to increase in the coming years, especially if the city's burgeoning research sector continues to grow. Rebalancing that ratio is tricky and will take years to fully realize.

For many years, the Bay Area city was primarily zoned for industrial and commercial use. However, the city has laid a strong policy foundation to correct this, with positive results thus far. Around 1,100 housing units are in the development pipeline. Roughly 35% are classified as affordable, including three 100% affordable projects. In fact, the city has gained widespread attention for its efforts to create a community where people can live, work, and play without ever using a car.



### Development bonuses code keeps projects profitable while maintaining local vision

Just like any other city, Emeryville developers must follow a set of design standards, such as height, density, or parking. Builders can exceed those standards under the city's (https://www.codepublishing.com/CA/Emeryville/#!/Emeryville09/Emeryville094.html#9-4.204)

Half of those points must come from building affordable nousing. The city also has an inclusionary housing policy that mirrors its state-mandated housing goals. The policy requires developments with more than 10 units to include a certain number of affordable units.



playgrounds, public art galleries, utility undergrounding, or small business assistance — things that make buildings feel like communities. Often, these benefits complement existing public services, including regional public transportation, or allow Emeryville to

realize long-time goals, such as a citywide

The remaining points can come from funding community benefits, such as

active transportation, parks, free transit,

biking and pedestrian pathway.

Once they have enough points, developers are allowed to exceed design standards. The city council then works with residents to determine which nearby projects can be funded with this money. The system helps ensure that developments get funded, residents get the services they need, building standards are met, and citywide goals are achieved.

"It's all about connecting any individual project to the greater vision for the city, not looking at it as a parcel-by-parcel thing — those are pieces to a greater puzzle," Emeryville Mayor John Bauters said.

The code also rewards density, which helps keep many projects profitable. Additionally, it helps mitigate any negative impacts on the surrounding community, such as increased traffic.

Jack Ghizzoni has been on both sides of the process, first as a resident and now as one of Emeryville's planning commissioners. Shortly after moving to the city in 2013, Ghizzoni



"It is extremely helpful to have residents articulate what they would like," Ghizzoni said. "We all live in different neighborhoods and communities. We all should have a role in determining what they look like. It's not good to just live passively in an environment that you don't feel happy with, when you do in fact have some input."

Navigating this process can be delicate and challenging. However, it is also one that can create vibrant, affordable, and sustainable communities.

"These decisions impact people's lives for decades," Ghizzoni said. "It's like a long, slow chess game, where you are really trying to put the pieces together over time and sometimes you are setting up an area so the preconditions are there for other good things to happen."

#### Staff, council, and developers march in lockstep

It is not just an innovative municipal code that keeps construction humming. In Emeryville, similar to (https://www.calcities.org/news/post/2022/03/09/manteca-shows-how-small-actions-cancreate-big-impacts-in-the-housing-market) other cities experiencing a housing construction boom (https://www.calcities.org/news/post/2022/03/09/manteca-shows-how-small-actions-can-create-big-impacts-in-the-housing-market), staff are empowered to expedite permits and approval.

"They all roll in one direction," said Welton Jordan, the chief real estate development officer for EAH Housing, which is active in the area. "They work with you to try to solve the issues. ... Once we receive this funding, we are on the clock to get this housing construction started and finished."

In an industry where a short delay can turn a profitable project into an infeasible one, such relationships are crucial.

"Something is always going to go wrong, that's just part of the business," Jordan said.
"You really do need the political support and the staff support to keep the process moving."



both populations. However, financing it proved difficult. Under prior law, senior housing could only be funded by tax credits if the units were reserved for seniors.

The city worked with the state and developers to pass

(ii) , which allows affordable housing developers to build housing for seniors and



transition-age foster youth using tax credits. The city is now working with EAH Housing to create a 68-unit intergenerational housing project.

Similarly, Emeryville leveraged its housing bonds to help construct Nellie Hannon Gateway shortly after the project plan was approved. The development will be built on a city-owned property. This allowed the developers, Resources for Community Development, to apply for funding they would not have been eligible for.

"The city has committed about \$16 million to this project and that is totally foundational to our ability to then leverage that for state and federal funds," said Jake Rosen, a project manager for the developer. "Without that, we would not have a project."

In addition to housing low-income families and those experiencing homelessness, the building will also house the Emeryville Citizens Assistance Program, a local nonprofit that provides access to food, counseling, and other vital services.

"It's making their application easier, which saves us money," Bauters said. "The state is giving money to the project and the locals get to put the money towards something else."
