#### **OBJECTIVE**

The purpose of this memorandum is to update recent Office of Economic Development activities targeted towards supporting local businesses through COVID recovery.

#### BACKGROUND

The month of June 2021 marks nearly 15 months since the onset of the COVID-19 pandemic and efforts to support businesses through economic recovery remains a high priority of the Office of Economic Development (OED). As nearly 600 small businesses were aided from the successful implementation of the D1 Business and Micro Business Relief Grants, and the JOBS 1st Program, OED initiated business outreach efforts through the new Foods of Garden Grove campaign to recognize the food and beverage industry in the midst of recovery, while further exploring future partnership with the SBDC under the Community Navigator Pilot Program. More updates are provided below in areas of Economic Development strategic planning and business development activities.

#### **DISCUSSION**

A roadmap to recovery has necessitated a comprehensive review of the City's 2018 Economic Development Strategic Plan to ensure priorities are focused toward sustainability and local economic recovery. To that end, an updated 2021 Economic Development Strategic Plan (2021 ESDP) will be presented at the upcoming August 24th meeting of which a few notable highlights are shared below:

OED actively and strategically utilized resources to expand social media presence, promote local services for new and existing businesses, and provide local support for workforce training remain key priorities. During COVID-19, local restaurants experienced extreme financial hardship and employee retention. The City's commitment to support small business and protect local jobs led to the creation of Foods of Garden Grove, an interactive website and virtual food tour "foodie map" at ggcity.org/foodsofgardengrove. Phase 1 provided direct business outreach support for 75 local small businesses. Implementation of Phase 2 adds an additional 75 restaurants by December 2021.

SBA recently unveiled the 2021 Community Navigator Pilot Program with the purpose of strengthening outreach to undeserved small businesses by partnering with local community organizations with established relationships. The OED contributed a partner application in collaboration with the Orange County/Inland Empire Small Business Development Center (SBDC) Network. If awarded, OED will focus activities toward supporting Garden Grove culturally, diverse businesses.

The OED continues to engage with the local SBDC and SCORE partners to resume in-person workshops. During COVID-19, the Garden Grove business community have had access to no-cost virtual business workshops via interactive webinars. The SBDC webinars are offered on Mondays, Wednesdays, and Fridays, and SCORE offers webinars five to six times a week on various topics such as website success, Google analytics, marketing trends, marketing plans, etc. The workshop links are placed on the OED's Business Portal and readily accessible to the City's residents and business community.

A comprehensive update of the OED website is slated in Fall 2021. Enhancement of business resources include: the addition of a data dashboard, Phase 2 of the Foods of Garden Grove program, project highlights and expanded inventory of available commercial properties in the City. The commercial properties inventory will detail vacancy spaces, vacancy rate, market rent, and inventory square feet.

OED's Workforce Activation and Readiness Program (WARP) has entered its next phase of program implementation. The program is funded with CARES Act funds directed to provide services to the homeless and those at-risk of homelessness. These services include employment services to Garden Grove residents to help individuals secure and maintain gainful employment.

In closing, the updated 2021 Economic Development Strategic Plan (2021 ESDP) will be presented at the upcoming August 24<sup>th</sup> meeting.

### OC Health Care Agency Officials Encourage Residents to Stay Safe to Keep County Open

(Santa Ana, CA) — As Orange County continues to experience increasing COVID-19 cases and hospitalizations, the Orange County Board of Supervisors and the OC Health Care Agency (HCA) leadership are encouraging residents to stay vigilant with COVID-19 prevention measures, testing and vaccinations in order to keep our residents safe and businesses open.

"Our County has been doing a tremendous job in getting the vaccines out into our community," said **Chairman Andrew Do**, First District. "It's safe, effective, free, and the surest way to help bring us out of this pandemic. We need our residents to continue with the preventative steps that allow us to draw closer together as a community."

Current data in Orange County shows that unvaccinated individuals are <u>over six times</u> more likely to become infected with COVID-19 than those who are fully vaccinated.

"Getting vaccinated doesn't just mean we are protecting ourselves – we are also protecting our family members, friends and coworkers," said **Vice Chairman Doug Chaffee,** Fourth District. "We are all part of the same community. We're asking residents to encourage loved ones to get vaccinated."

Between July 15 and July 21, the county experienced an increase in the seven-day average case rate, from 2.95 to 6.1 per 100,000 people, with the average number of daily COVID-19 cases increasing from 121 to 209. The positivity rate also increased from 2.2 percent to 4 percent, and hospitalizations jumped from 119 to 149 per day.

"We are still seeing an uptick in COVID-19 cases and hospitalizations, especially among those who are not yet fully vaccinated," said **Dr. Regina Chinsio-Kwong**, Deputy County Health Officer. "We expected to see an increase when mask requirements were lifted and physical distancing was reduced, but we want to take every opportunity we can to reduce the spread of infection. This means staying focused on preventive measures to protect those who are unable to be vaccinated."

Prevention continues to be a critical piece of the Agency's message for county residents.

"We are strongly encouraging everyone to avoid large crowds, where it is easy for the virus to pass from person to person," said **Dr. Clayton Chau**, HCA Director and County Health Officer. "Regardless of your vaccination status, wear a mask if you're around someone at risk, with people whose vaccination status is unknown especially indoors, or have unvaccinated children or other loved ones at home. If you are not fully vaccinated, you <u>must</u> wear a mask indoors in accordance with guidelines from the California Department of Public Health (CDPH)."

The agency also reminds those who experience COVID-19 symptoms to get tested, regardless of their vaccination status. Self-collection, at-home COVID-19 test kits can be ordered at no cost by visiting <a href="https://www.ochealthinfo.com/covidtest">www.ochealthinfo.com/covidtest</a>.

Individuals seeking information about the COVID-19 vaccines, are encouraged to follow credible sources to learn more about their benefits, safety and effectiveness. The World Health Organization, for example, recently updated a list of questions and answers (Q&A) to address COVID-19 vaccine <u>safety</u>. Other sources include the <u>Centers for Disease Control and Prevention</u>, the <u>CDPH</u>, the <u>Food and Drug Administration</u>, and the <u>American Academy of Pediatrics</u>.

Funcionarios de la Agencia del Cuidado de la Salud del Condado de Orange alientan a los residentes a protegerse para mantener el Condado abierto

(Santa Ana, CA) - A medida que el Condado de Orange continúa experimentando un aumento en los casos de COVID-19 y en las hospitalizaciones, la Junta de Supervisores del Condado de Orange y los líderes de la Agencia del Cuidado de la Salud del Condado de Orange (HCA, siglas en inglés) están alentando a los residentes a permanecer atentos a las medidas de prevención de COVID-19, a las pruebas y a las vacunas para mantener a nuestros residentes seguros y a los negocios abiertos.

"Nuestro Condado ha estado haciendo un tremendo trabajo proporcionando las vacunas en nuestra comunidad", dijo Andrew Do, Supervisor del Primer Distrito y presidente de la Junta de Supervisores de OC. "Es seguro, eficaz, gratuito y la forma más segura de ayudar a salir de esta pandemia. Necesitamos que nuestros residentes continúen con las medidas preventivas que nos permiten acercarnos como comunidad."

Los datos actuales en el Condado de Orange muestran que las personas no vacunadas tienen más de seis veces más probabilidades de infectarse con COVID-19 que las que están totalmente vacunadas.

"Vacunarse no sólo significa que nos estamos protegiendo a nosotros mismos - también estamos protegiendo a los miembros de nuestra familia, amigos y compañeros de trabajo", dijo el **Vicepresidente de la Junta de Supervisores de OC, Doug Chaffee, Supervisor del Cuarto Distrito.** "Todos formamos parte de la misma comunidad. Pedimos a los residentes que animen a sus seres queridos a vacunarse".

Entre el 15 y el 21 de julio, el condado experimentó un aumento de la tasa promedio de casos en 7 días, de 2.95 a 6.1 por cada 100,000 personas, y el número promedio de casos diarios de COVID-19 aumentó de 121 a 209. La tasa de positividad también aumentó del 2.2% al 4%, y las hospitalizaciones pasaron de 119 a 149 por día.

"Seguimos observando un aumento de los casos de COVID-19 y de las hospitalizaciones, especialmente entre los que aún no están totalmente vacunados", dijo la **Dra. Regina Chinsio-Kwong, subdirectora de Salud del Condado.** "Esperábamos ver un aumento cuando se levantaron los requisitos de la mascarilla y se redujo el distanciamiento físico, pero queremos aprovechar todas las oportunidades que podamos para reducir la propagación de la infección. Esto significa seguir centrados en las medidas preventivas para proteger a los que no pueden vacunarse."

La prevención sigue siendo una pieza fundamental del mensaje de la Agencia para los residentes del condado.

"Estamos alentando encarecidamente a todos a evitar las grandes multitudes, donde es fácil que el virus pase de persona a persona", dijo el **Dr. Clayton Chau, Director de HCA y Funcionario de Salud del Condado.**"Independientemente de su estado de vacunación, use una mascarilla si está cerca de alguien de riesgo, con personas cuyo estado de vacunación se desconoce, especialmente en interiores, o tiene niños no vacunados u otros seres queridos en casa. Si no está totalmente vacunado, debe usar una mascarilla en interiores de acuerdo con las normas del Departamento de Salud Pública de California (CDPH, por sus siglas e inglés)".

La agencia también recuerda a quienes experimentan síntomas de COVID-19 que deben hacerse la prueba, independientemente de su estado de vacunación. Los kits de prueba de COVID-19 para la auto-recolección en casa se pueden pedir sin costo alguno visitando <a href="https://www.ochealthinfo.com/covidtest">www.ochealthinfo.com/covidtest</a>.

Se recomienda a las personas que busquen información sobre las vacunas contra la COVID-19 a que sigan fuentes creíbles para saber más sobre sus beneficios, seguridad y eficacia. La Organización Mundial de la Salud, por ejemplo, ha actualizado recientemente una lista de preguntas y respuestas (Q&A) para tratar el tema sobre la seguridad de la vacuna COVID-19. Otras fuentes incluyen los Centros para el Control y la Prevención de Enfermedades, el CDPH, la Administración de Alimentos y Medicamentos y la Academia Americana de Pediatría.

### Unsecured Property Tax Bills for FY 2021-22 Mailed and Available Online Due Date is August 31st

Santa Ana, Calif. – Orange County Treasurer Shari Freidenrich announced that 54,478 unsecured property tax bills totaling over \$320 million have been mailed to the names of the property owners on the most recent tax roll. These unsecured property tax bills are now available online at ocgov.com/octaxbill.

These unsecured property taxes are related to business property, leased equipment, boats and aircraft for fiscal year 2021-22 and are due on August 31. Treasurer Shari L. Freidenrich recommends that taxpayers skip the line and pay online at ocgov.com/octaxbill. There is no service fee to pay online by eCheck (bank account), and taxpayers can pay online up to midnight on August 31 and receive same-day credit and a receipt that can be printed or emailed.

In person payments are due by 5 p.m. at the County Service Center or can be dropped off in the Payment Depository Box located on Ross Street with adjacent parking on August 31 by midnight. Unsecured property tax bills not paid by the due date will be charged a 10 percent penalty plus a \$75 collection fee. Taxpayers who pay by mail must have a U.S. Postal Service date stamp for August 31 or earlier. Taxpayers mailing the payment close to the due date should have payment envelopes hand cancelled and can go to ocgov.com/postmarks for more information to ensure that all mailed payments are timely received.

"The last year has been devastating for many property owners. I understand and sympathize with the financial impacts that COVID-19 has caused Orange County taxpayers and businesses, "said Treasurer Freidenrich. "Current State law requires that the owner of record as of January 1, 2021 be responsible for paying the FY 2021-22 unsecured property tax bill even if the unsecured property has been sold or otherwise disposed of after January 1, 2021. Unlike secured property taxes, unsecured property taxes are not prorated by time of ownership." The new owner of the unsecured property is not responsible for paying the property taxes on the personal property purchased until the new lien date of January 1, 2022. Treasurer Freidenrich encourages taxpayers to sign up for text or email unsecured property tax information at ocgov.com/ocunsecuredreminder.

Taxpayers can view prior tax bills online and also view an online statement to see if any current or delinquent unsecured property taxes are owed. This information is available by going to ocgov.com/octaxbill and scroll to the Unsecured Property Tax Bill section in the middle of the page. You can search by business name, the tax collector reference number (TC Ref), the CF Number, the N Number or the tax year and assessment number.

Of the 54,478 unsecured property tax bills that were generated, assessments were sent to 43,002 businesses, 16,760 boat and aircraft owners and 15,070 leased equipment owners. The unsecured property low value exemption for business equipment, boats and aircraft was increased for FY 2021-22 from \$3,000 to \$7,500 by the Board after a request from the Treasurer and Assessor. There are 39,331 fewer assessments in 2021 than 2020 including a decrease of 21,877 business assessments, lowering tax burdens on small businesses.

Redistricting is the regular process of adjusting the lines of voting districts in accordance with population shifts. The redistricting process is done every 10 years for local, state and federal governmental bodies by using updated Census data. The 2021 County of Orange redistricting process will use data from the 2020 Census. Release of the Census data from the United States Census Bureau has been significantly

delayed by the COVID-19 pandemic. The delayed release of adjusted data from the State is expected by the end of September 2021. Local jurisdictions, including the County of Orange, must complete the redistricting process by no later than December 15, 2021, to allow for the new supervisorial districts to be ready for use in the June 7, 2022 primary election.

#### Masks are mandatory again at OC Superior Court in Santa Ana after 2 test positive for COVID-19

The Orange County Superior Courthouse in Santa Ana will return to a mandatory mask mandate for all employees and visitors on Monday, July 26, regardless of vaccination status, after two people in the building tested positive for COVID-19, officials announced on Sunday.

Officials were notified Friday evening that the two people may have contracted coronavirus, Orange County Superior Court spokesman Kostas Kalaitzidis said. Those cases were confirmed at about 10:30 a.m. Sunday.

The process to re-implement mandatory mask use at the Santa Ana courthouse began immediately afterward, Kalaitzidis said. Previously, those who were fully vaccinated were allowed to enter without wearing a mask. However, court employees were not asking for proof of vaccination, and visitors were held to the honor system.

The change is in line with guidance from numerous state and county health agencies, Kalaitzidis said. It is meant to protect those coming and going from the building, and everyone they subsequently come into contact with, from spreading the virus.

"We are a part of the community," Kalaitzidis said.

Acting Presiding Judge Maria D. Hernandez signed the order.

Authorities were unable to specify whether the patients were visitors or staffers, citing medical privacy laws. Health officials have identified where and when they became infected, and have notified anyone who may have been in contact with them, Kalaitzidis said.

The order will expire two weeks from Monday if no new cases are reported at the courthouse. But it could be extended if officials learn of another person testing positive for COVID-19 who may have been in the building during that time.

Children under 3 years old are exempt.

More than 3,573,840 vaccine doses have been distributed in Orange County, with 54.9% or 1,743,251 fully vaccinated as of Wednesday, July 21, according to the California Department of Public Health. Vaccination numbers are updated weekly.

As of Friday, 3,170 new COVID-19 infections were reported in Orange County in the last 14 days. So far, more than 260,000 people in the county have contracted the disease.

Masks already are being required at Harbor Court in Newport Beach after two people who had been at that facility tested positive. That order was put into place for two weeks and is scheduled to be lifted on July 28.

And with COVID-19 cases again surging in San Bernardino County, courts officials announced that starting Monday, July 26, everyone who enters a courthouse there must wear a mask even if vaccinated.

The number of COVID-19 patients in San Bernardino County hospitals last week reached its highest count since March, according to data released Wednesday. County hospitals reported 149 confirmed COVID-19 patients, the most since March 24, when 144 patients were hospitalized.

Health officials say an increase in infections nationwide is attributable to unvaccinated people getting sick and fewer restrictions on gatherings and social distancing.

An Associated Press analysis of data from the Centers for Disease Control and Prevention from May shows that "breakthrough" infections in fully vaccinated people accounted for fewer than 1,200 of more than 107,000 COVID-19 hospitalizations. That's about 1.1%. And only about 150 of the more than 18,000 COVID-19 deaths in May were in fully vaccinated people. That translates to about 0.8%, or five deaths per day on average.

### Motorcyclist killed in Garden Grove after van makes 'unsafe' turn into oncoming traffic

A motorcyclist died Saturday after a van made an unsafe turn into oncoming traffic, Garden Grove police said.

The crash occurred at Haster Street and Lampson Avenue before 6:30 p.m.

When Orange County fire paramedics got to the scene, they found the motorcyclist dead, police said in a statement. The motorcyclist has not been identified by the coroner's office yet.

Garden Grove police said detectives determined the van caused the collision with the motorcycle by making an "unsafe" turn into traffic. Officials didn't say which direction each vehicle was headed at the time of the crash.

The van driver stayed at the scene and has not been arrested. Detectives are investigating to determine whether alcohol or drugs played a part in the crash.

## Cities urged to update contact information at "Call Before You Dig" call centers

Jul 28, 2021

Cities with outdated information could end up out of compliance with requirements in new legislation.

Attention all cities that own or maintain underground facilities. As of January 1, 2021, any entity with underground facilities are required to respond to "call before you dig" excavation requests through one of two California call centers, <a href="DigAlert">DigAlert</a> (<a href="https://docs.digalert.org/display/MEM/Electronic+Positive+Response/">DigAlert</a> (Southern California) and <a href="USA North">USA North</a> (<a href="https://usanorth811.org/positive-response">https://usanorth811.org/positive-response</a>) (Northern California), that manage communication between excavators and utility operators.

The call centers have been in operation for years with the goal of preventing potentially deadly digging accidents by providing utility operators notification of any excavation planned near their underground facilities. All "excavators" — anyone digging at a job site — are required to notify the appropriate call center before work begins. "Operators" or those who own or maintain buried infrastructure, are required to mark the location of any subsurface utilities at the worksite or supply a map of the utilities.

What's new is that under AB 1166 (Levine, 2019)

(https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill\_id=201920200AB1166), it is now mandatory for operators, which include public works departments, to enter their response to the excavator's request electronically through the call center

unless an extension is granted by the California Underground Facilities Safe Excavation Board for "good cause." Members granted an extension will have until December 31, 2021 to implement an "Electronic Positive Response."

Electronic Positive Response improves safety by providing excavators with an online location to view the responses of facility owners—including requests to contact the facility owner—before arriving onsite.

According to the California Underground Facilities Safe Excavation Board, about half of all cities, special districts, or counties have inaccurate contact information registered with the call centers, leading to a lack of compliance by cities to submit their electronic positive response in a timely fashion.

The call centers indicate that many of their contacts are utility billing departments that are disconnected from operational functions. Preferred contacts include heads of public works, city managers, and assistant city managers.

To prevent accidents and ensure cities are in compliance with the new legislation, cities should contact their respective call center <a href="DigAlert">DigAlert</a>

### Cal Cities highlights more than 50 priority bills

Last Thursday, the League of California Cities briefed city officials on bills of interest currently working their way through the legislative process.

The webinar, Summer Recess Briefing on Priority Bills, provided city officials with a briefing on major bills cities should consider advocating for or against once the Legislature returns from its summer recess on Aug. 16. #### Governance, Transparency, and Labor Relations

Seven bills, including AB 339

(https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill\_id=202120220AB339) (Lee) were highlighted. This measure would require city councils and boards of supervisors in jurisdictions with over 250,000 residents to provide in-person and a two-way telephonic option or a two-way internet-based service option for the public to attend their meetings. Cal Cities opposes the bill, even though it has been significantly amended.

The Cal Cities Board of Directors took action to oppose AB 237 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill\_id=202120220AB237) (Gray). This measure would prohibit public employers from terminating, or threatening to terminate, the health care coverage and related benefits of employees and their families during an authorized strike. If passed, the bill could lead to longer strikes — which are currently infrequent and short — thus disrupting the flow of public services.

#### Housing, Community and Economic Development

Dozens of housing, land use, and planning bills have been sidelined or failed to make it out of committee. However, **AB 816**

(Caballero) will probably return in the next legislative cycle. The bills that remain are critically important.

SB 8 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill\_id=202120220SB8)

(Skinner) would extend the Housing Crisis Act sunset date to 2030. The 2019 Act declared a statewide housing crisis and froze nearly all development-related fees once a developer submits a "preliminary" application, including essential project-specific fees. Cal Cities opposes the measure since there is no evidence it needs to be extended.

Two bills — AB 500 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml? bill\_id=202120220AB500) (Ward), and AB 602

(Grayson) — were recently amended. As such, Cal Cities is reconsidering its position on AB 500 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml? bill\_id=202120220AB500), a measure related to coastal development and affordable housing. However, Cal Cities remains opposed to AB 602 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml?bill\_id=202120220AB602), which would make significant changes to laws governing local development impact fees and create new state and local costs.

Cal Cities also opposes AB 1401

The bill's definition of "public transit" would give developers and transit agencies — who are unaccountable to local voters — the power to determine parking requirements. Additionally, the bill could negatively impact the State's Density Bonus Law by providing developers parking concessions without also requiring them to include affordable housing units in the project.

bill\_id=202120220SB16) would expand the categories of records subject to disclosure under the California Public Records Act (CPRA), impose new requirements for record retention specify a timeline for a law enforcement agency to provide public records to the requester, and would outline restrictions related to attorney-client privilege. Cal Cities is reconsidering its position on both bills

This year has been good for cities on the revenue and taxation legislation front. In previous years, bills often created tax credits and exemptions at the expense of cities. This year, those bills were sidelined or stalled, thanks to the advocacy of Cal Cities members.

#### Transportation, Communications, and Public Works

Three transportation bills and six communication bills were highlighted. Of particular note is AB 970 (https://leginfo.legislature.ca.gov/faces/billNavClient.xhtml? bill\_id=202120220AB970) (McCarty), which Cal Cities opposes. The bill would create a shorter permitting process for electric vehicle charging stations. For cities with finite resources, focusing on certain permit types with very short turnarounds will result in fewer resources to expedite other types of permits, including those related to affordable housing, health and safety, and other industries. Moreover, the bill does not distinguish between relatively simple permittees, like homeowners, and more complex installations, such as large public charging stations.

### Guide to Local Recovery Update: July 28

Cal Cities, along with 400 city officials and other organizations, signed a letter about the need for federal infrastructure funding.

Written by the National League of Cities (NLC), the letter urged Congressional leadership to pass a comprehensive infrastructure package and outlined the top priorities of local governments. City officials are encouraged to sign a similar letter to their congressional delegation. Cal Cities also released an updated version of its American Rescue Plan Act revenue loss calculators, which includes minor changes based on member feedback. 


## Eureka's Redwood Sky Walk takes conservation and education to new heights

Jul 28, 2021

It's hard not to get immersed in the surreal experience of northern California's latest attraction: Eureka's Redwood Sky Walk.

The Redwood Sky Walk in Eureka is the highest skywalk among redwood trees in the world and the longest skywalk in the Western U.S. Just under a quarter mile to the end and back, the Sky Walk is 100 feet above ground within the city of Eureka's treasured Sequoia Park and Sequoia Park Zoo. This project is a mighty example of a city demonstrating how #LocalWorks on many levels – in fact, the sky is the limit.



"It's great for the community," said Brian Archuleta who visited the attraction Father's Day weekend. "It'll definitely bring some more people into this area."

In fact, the Redwood Sky Walk recorded at least one visitor from every state in the U.S. within the first two weeks of its grand opening on June 4, 2021.

Brad Nissen and Lauren Diaz heard about the Redwood Sky Walk from social media. Then they saw it in the New York Times.

"We found out about it through a Tik Tok," said Diaz. Diaz was visiting Eureka from Oregon so she and Nissen decided to visit.

The attraction offers visitors a new way to experience the history, nature, wildlife, and diverse ecology of one of the nation's most inimitable regions.

"Conservation and education are huge components of our zoo," explains Eureka City Manager Miles Slattery. "We saw this was such a unique habitat on the backside of the zoo that could provide a huge opportunity for education for visitors."

There are no stairs, making the experience compliant with the Americans with Disabilities Act (ADA-accessible), except for an optional adventure portion.

The \$4 million project was entirely funded by grants, the California state parks system, local lodging alliances in Arcata, Eureka, and Humboldt, St. Joseph and Redwood Memorial Hospitals, and the Sequoia Park Zoo Foundation Community donors.

# Federal, state, and local transportation infrastructure spending creates \$200 billion in economic benefits in California annually

Cal Cities sponsored report is accompanied by a new, searchable online database that generates customized reports and breaks down the economic benefits for each region.

The League of California Cities and a coalition of partners produced a first-of-its-kind (https://www.catransportationjobs.com/wp-content/uploads/2021/07/California-Economic-Report-2021.pdf) report (https://www.catransportationjobs.com/wp-content/uploads/2021/07/California-Economic-Report-2021.pdf) on the state's transportation infrastructure and a (https://www.catransportationjobs.com/) related, customizable database (https://www.catransportationjobs.com/) demonstrating the economic benefits locally. Released in the middle of ongoing, federal-level infrastructure negotiations, the report found that upcoming spending on federal, state, and local infrastructure will generate nearly \$200 billion in economic activity in California annually and will support 700,000 jobs per year. The findings make clear that the construction, maintenance, and operation of the state's infrastructure network is a major economic driver that benefits all Californians.

According to the report, in the next 10 years, government investments in California's transportation infrastructure will grow from \$40.4 billion in 2021 to \$52.6 billion in 2030. That equates to a return of \$4.30 in economic activity for every \$1 spent on infrastructure.

"This report underscores how strategic investment in transportation infrastructure creates strong ripple effects in our cities, including an increase in jobs, economic activity, and tax revenues, while at the same time ensuring equitable access to multiple transportation options for all Californians,"

The "Economic Impacts of Highway, Street, Bridge, and Transit Investment in California" is the first report to examine the impacts of transportation infrastructure spending on all sectors of the California economy, not just the transportation sector. The report uses a series of sophisticated models to quantify both the immediate economic activity from increased highway, street, bridge, and transit program spending levels in California and the longer-term user benefits that accrue from improving the transportation system.
